BoHof GmbH Terms and conditions

1. Prices:

All prices are gross prices in Euro including the statutory value added tax.
If the period of 30 days between order acceptance and the start of the event is exceeded, BoHof GmbH reserves the right to make a price change.

2. Conclusion of contract:

All offers are subject to change until the order is accepted.

3. Number of participants:

The final number of persons must be announced in writing 7 days before the start of the event, otherwise the number of menus estimated in the offer will be charged.

4. Payment:

4.1. Payment can be made on site in cash, by credit or debit card.

4.2. An invoice can be issued with a pre-filled declaration of assumption of costs, which has a payment term of 10 working days from the date of invoice.

4.3. Upon conclusion of the contract, 50% of the agreed minimum turnover is due, the remainder upon receipt of the final invoice.

5. House rules:

5.1. The opening hours of the restaurant are from Monday to Saturday until 11:30 p.m., from 00:00 a.m. a service surcharge of € 250.00 per hour or part thereof will be charged.

5.2. An extension of the opening hours is possible until a maximum of 2:00 a.m.

5.3. Music is permitted via the in-house music system. The customer shall be fully liable for any damage and penalties resulting from non-compliance with the decibel limits.

5.4. The stay in the outdoor area of the restaurant is permitted until a maximum of 11:00 p.m. under the permitted decibel limits. If this volume is not adhered to, the outdoor area must be cleared. The customer is fully liable for any damage and penalties resulting from non-compliance with the decibel limit

6. Cancellation:

The customer has the right to withdraw from the contract at any time. Insofar as no other written agreements have been made between the customer and BoHof GmbH, BoHof GmbH shall be entitled to reasonable compensation as follows:

Up to 11 days before the start of the event free of charge.

Up to 10 days before the start of the event, 10% of the agreed offer amount will be charged.

Up to 2 days before the start of the event, 80% of the offer amount will be charged.

On the day of the event itself, 100% of the offer amount will be charged.

In the event of a no-show, 100% of the offer amount will be charged.

Additional services provided by third-party suppliers, which are pre-ordered in consultation with the customer and can no longer be cancelled, will be charged at 100%.

7. Place of jurisdiction and place of performance:

7.1. The place of jurisdiction and place of performance for all disputes is Munich. By placing an order, our General Terms and Conditions of BoHof GmbH are recognized. Amendments and deviations from these contractual terms and conditions must be made in writing to be effective.

7.2. With the publication of these General Terms and Conditions, all previous versions lose their validity.
